State DC:0-5 Crosswalks

This table compiles crosswalks from disorders in the DC:0-5 to corresponding disorders in the DSM-5 and ICD-10, as well as to state Medicaid-billable ICD-10 diagnostic codes. The first three columns crosswalk DC:0-5 disorders to their corresponding DSM-5 and ICD-10 disorders. The next columns show information from Zero to Three and state DC:0-5 crosswalks and indicate the ICD-10 diagnostic code each state uses in its Medicaid billing system. Hyperlinks to the states' crosswalks (where available online) are in the table's first row. This table will be updated regularly.
